- 1. Question:** In Section 2.4 of the Specifications, the Warren Road site, it shows the city and zip code as Halethorpe, MD 21227. Is this correct?

Answer: Warren Road is in Cockeysville and the city and zip on this site is incorrectly shown. Warren Road is in Cockeysville and the zip code is 21030.

- 2. Question:** On page 11 of the bid package (or side 2) of the TIN and certification form, there is a box for MBE/WBE certification numbers. Below that is a City of Baltimore and MDOT certification numbers. Do we only need to fill this in if we are an MBE or WBE?

Answer: The heading of that section is for WBE/MBE certification numbers. So only fill in if you are an MBE or WBE vendor.

- 3. Question:** On page 21, Section 4.1, the bid book states: "Mowing is to be bid as "per mow" price, except for ESL which is to be bid as per acre," but on page 26, on the price sheet, the ESL is line item 5 and for "unit" it says "per mow" and not "per acre".

Answer: The pricing page is in error. Please see the revised pricing page which correctly shows the quantity of 23 and the unit of measure as acre. Please indicate your price per acre.
